"Purpose, Processes, Persons, Places in Public Administration"

scheduled on Tuesday, November 6, 2025 (from 3 p.m. to 5 p.m., Czech time)

The colloquium is organized by the Faculty of Law, Palacký University in Olomouc as a part of project: Intenzivní podpora vědeckovýzkumné a pedagogické spolupráce a odborného růstu akademických pracovníků a studentů Taras Shevchenko National University of Kyiv (Projekt 4Ps)¹.

The colloquium will be held in **online form** (via the Zoom application).

The colloquium is open to the wide community of lawyers and law students. We welcome contributions (lasting from 10-15 minutes) from academics and students on a topic of their choice (registration is required for both active and passive attendance). A detailed list of papers will be published one week before the colloquium.

Thematic focus:

The colloquium focuses on four priorities (4Ps) that should be emphasized in relation to public administration. These are purpose (the purpose of public administration), processes (processes and procedures within public administration), persons (human resources and recipients of public administration), and places (the geography of public administration).

From the perspective of the purposes of public administration, it is particularly important to emphasize that good public administration should be effective, transparent (open), and accountable.

As far as processes and procedures in public administration are concerned, it is necessary to focus on new trends such as the use of AI, process automation, and the overall digitization and modernization of public administration within individual sectors (internal administration, healthcare, education, transport, building administration, and others).

The human element in public administration is also crucial and irreplaceable. This applies to both sides of the relevant administrative procedural relationships. It is necessary to focus both on the quality of state and public services, i.e., on the status of employees who perform public administration on a daily basis, on the regulation of their rights and obligations, and on the status of the recipients of public administration (on the other side of the relationship), especially when it comes to vulnerable groups (people with disabilities, seniors, refugees, or persons affected by the war in Ukraine).
